After careful verification of the documents alongwith

D.E.O. Ferozepur and D.P.I (Private Aided Schools). The required  
N.O.C. is issued on the following conditions.

1. In future on the basis of complaint/inspection, if it comes  
to notice that the application based on false information has been  
submitted while applying for N.O.C. or the instructions issued by  
Punjab Govt. from time to time are not abided by the school and as  
such the declarations given in the form of affidavit are not adhered  
to in that case N.O.C. can be withdrawn at any time.

It will be compulsory for you to teach Punjabi upto 10th  
class in your school and C.B.S.E. will make arranger for the examina-  
tion of Punjabi. In case of non-compliance N.O.C. will be withdrawn

3. After getting affiliation from C.B.S.E. the management  
of the above noted school will be bound to pay salary and other  
allowances like govt. servants to its teaching staff as well as non  
teaching staff. In case of non compliance, N.O.C. will be withdrawn.

4. You your-self and your management will make it sure  
to supply necessary information to the D.E.O. of your district

or any Senior Officer of the Education Department as and. When it is asked for by them and it will give them required co-operation.
